PERFORM THE FOLLOWING INSPECTIONS WITHIN 60 DAYS PRIOR TO REGISTRATION OF AN EASYCARE VEHICLE SERVICE CONTRACT ON A MOTOR TREND CERTIFIED ADVANTAGE (MTCA) VEHICLE*.

NOTE: A 10 - 15 MINUTE ROAD TEST IS REQUIRED AS PART OF THIS INSPECTION.

The Dealer agrees to inspect used vehicles and to ensure that ALL PARTS AND COMPONENTS COVERED BY THE **EasyCare® VEHICLE SERVICE CONTRACT** ARE FUNCTIONING PROPERLY AT THE TIME OF SERVICE CONTRACT SALE.

If the vehicle is within 1,500 miles of a major maintenance requirement (e.g., timing belt/chain replacement), as specified by the vehicle's manufacturer, the Dealer agrees to perform the maintenance.

The Dealer also agrees to perform the following procedures on every **MTCA** used vehicle before it is offered for sale with an **EasyCare®** Vehicle Service Contract:

I. INITIAL INSPECTION

- ✓ **ODOMETER READING** is supported by the general condition of the vehicle.
- ✓ **CHECK** for presence of lube sticker or maintenance log for support of mileage.
- ✓ **CHANGE OIL** and **OIL FILTER** prior to sale.
- ✓ **REPAIR DENTS** that can be repaired using Paintless Dent Repair process.
- ✓ **INTERIOR** and **EXTERIOR** cleaning and polishing.
- ✓ **REPAIR** and **REPLACE** wear parts (bulbs, floor mats, wiper blades).

II. UNDER HOOD

- ✓ **ENGINE** block, cylinder heads, intake and exhaust manifolds check/correct for cracks.
- ✓ **CHECK FOR AND CORRECT ALL LEAKS.**
- ✓ **AUTOMATIC TRANSMISSION FLUID** is at the prescribed level and is not contaminated or discolored.
- ✓ **COOLANT** is at the prescribed level and is not contaminated. +/-
- ✓ **PRESSURE TEST COOLING SYSTEM** to check/correct leaks.
- ✓ **CHECK/CORRECT** cooling fan operation.
- ✓ **POWER STEERING** pump reservoir and gear box are at the prescribed fluid level and system shows no evidence of leaks or noises.
- ✓ **BRAKE MASTER CYLINDER** is at the prescribed fluid level and shows no evidence of leaks.
- ✓ **BATTERY** charge is at prescribed level, cables are corrosion-free and properly secured.
- ✓ **AIR CLEANER/FUEL INJECTORS** are clean.

III. UNDER VEHICLE

- ✓ **VISUAL INSPECTION** under vehicle.
- ✓ **TRANSMISSION CASE** is free of cracks and leaks.
- ✓ **STANDARD TRANSMISSION FLUID** is at the prescribed level (also transfer case on 4x4s) and no leaks.
- ✓ **CV BOOTS** are free from cracks, deterioration or leaks.
- ✓ **STRUTS** not leaking or weak.
- ✓ **INSPECT BRAKE WEAR** (Front, Visual - Rear, Pull Both).

- ✓ Pads and linings must have at least 4MM of life remaining.
- ✓ **SUSPENSION SYSTEMS** (i.e., Ball Joints, Tie Rods) checked for wear, looseness. Replace any worn or loose parts.
- ✓ **SUSPENSION ALTERED (Lifted or lowered)**

- ✓ **REAR AXLE FLUID** is at the prescribed level (also front axle on 4x4s) and housing is not leaking.
- ✓ **TIRES** must have at least 4/32" of tread depth remaining.

IV. ROAD TEST

- ✓ **ENGINE** is operating properly and shows no obvious signs of problems (i.e., smoking, poor performance, rough idle, etc.).
- ✓ **ENGINE OIL PRESSURE AND OPERATING TEMPERATURES** are within normal hot/cold range levels.
- ✓ **AUTOMATIC TRANSMISSION** is shifting smoothly and quietly when cold and at full operating temperature.
- ✓ **STANDARD TRANSMISSION** is shifting properly and quietly (also transfer case on 4x4s).
- ✓ **VIBRATION** in the drive line, if any, has been corrected.
- ✓ **ELECTRICAL** all manual switches (e.g., power window, heating fan, windshield wiper, door locks, etc.) have been inspected for proper operation. And all grids on the heated back glass (if equipped) are working properly. Radio/Cassette/CD/DVD/GPS Player fully operational. All gauges work and display properly.
- ✓ **AIR CONDITIONING** has been inspected for proper operation and any refrigerant leaks are corrected.
- ✓ **STEERING** has been checked for proper operation.
- ✓ **BRAKES & CALIPERS** have been checked for proper operation and leaks. Replace pads and linings, if worn below 4MM level.
- ✓ **PARKING BRAKE** has been checked for proper operation.
- ✓ **UNUSUAL NOISES** Correct conditions causing unusual noise in engine, transmission and/or drive axle.
- ✓ **EMISSION SYSTEM** All parts are functional and meet required standards.
- ✓ **CV JOINTS** No abnormal noise on hard left or right turns.
- ✓ **SPECIFY TIRE SIZE** _____
